

Thank you for entering the Sacramento Dog Training Club's AKC Agility trials to be held on November 27, 28, and 29, 2015. Event site is the Murieta Equestrian Center, 7200 Lone Pine Dr. Rancho Murieta, CA 95683.

Upon acceptance of your entry, you were emailed an entry confirmation. Please ensure you have reviewed that confirmation carefully.

MURIETA WAIVER: The Murieta Equine Complex requires all persons taking part in activities on the property to sign the Murieta Release Waiver. If you did not send a signed waiver with your entry to any of the following 2015 AKC agility trials; Portuguese Water Dog Club, Sacramento Dog Training Club or TRACS, you must complete one and turn it into the scoring office before your first run of the weekend. A list of those owing waivers will be posted on the table outside the scoring office, near the course maps and armband stickers. You must turn in a signed waiver BEFORE your first run of the weekend.

CRATING: Crating will be extremely tight this year, some areas previously used for crating are now unavailable. In order to insure there is a crating space for everyone entered, please take the minimum amount of space needed for your crate or ex-pen, and only in the areas marked for crating. There will be no crating in between rings or along the wall near the entrance to the rings. The Trial Committee reserves the right to require people to reduce their crating area to the minimum needed for crates and ex-pens if conditions warrant.

TRIAL SCHEDULE - GENERAL INFORMATION

JUDGING BEGINS: 9am on Friday and 8am on Saturday and Sunday. See detailed schedule below

CHECK-IN: Opens at 8:15 am on Friday and 7:15 Saturday and Sunday.

WALK THROUGHS: First walk through each day will begin no later than 15 minutes prior to the start of the first class. General Walk through in any ring may begin as soon as the judge approves the course. Subsequent classes and walk troughs will start when the previous class is completed.

COMPETITOR BRIEFING: General competitor briefing 8:40 am on Friday, 7:40 am on Saturday and Sunday

INITIAL JUDGE'S BRIEFING: Will take place 15 minutes prior to the start of the first class in each ring. <u>Friday - 8:45, Saturday & Sunday - 7:45</u>. Subsequent judges' briefings will immediately precede each class.

Novice and Open Std, JWW, FAST All heights walk together

T2B All heights will walk the course together before judging begins

Master/Excellent FAST All heights will walk the course together before judging begins

Master/Excellent Standard and JWW 5 walk through groups each day as follows:

<u>IMPORTANT COMPETITOR NOTE:</u> DO NOT, under any circumstances, allow your dog to relieve itself anywhere under, in or on the arena floor, structure, or anything man-made anywhere on the site. Additionally, be sure to pick up after your dogs regardless of where or when they leave a mess. Failure to following these directions is cause for a Bench Committee hearing.

<u>UNATTENDED DOGS:</u> <u>In accordance with AKC rules, all dogs must be on leash and attached to a human being.</u> Please do not tie your dog to the fences, leave them in chairs, or in an unattended down stay next to the ring while walking your course. If you are early in the running order, you may bring a crate to the warm up area to stage your dog so you can be ready immediately following the walk though. However, you will have to remove it after your run to keep congestion down near the front of the rings.

DIRECTIONS:

From Sacramento/Bay Area and other points west/south: Take Hwy 50 east towards Lake Tahoe. Exit at Sunrise Blvd. Turn right off the exit ramp and proceed for 7.4 miles to Jackson Road (Rt 16). Turn left on Jackson Road and proceed 7.1 miles to Lone Pine Rd. Turn right on Lone Pine. Murieta Equine Complex is immediately on your right.

<u>From Reno</u>: Take Hwy 80 towards Sacramento. Exit at Sierra College Blvd. Turn south. Sierra College Blvd becomes Hazel Ave. Follow Hazel Ave to Hwy 50 west. Follow Hwy 50 to Sunrise Blvd exit. Turn left off exit ramp and follow directions above.

RV PARKING: Is by advance reservation only and there are limited hook ups. Contact Murieta Equine Center at (916)985-7334. SDTC has no involvement with RV parking/camping. Except by prior arrangement, there is NO RV Parking in between the two arenas. If you have not secured an RV reservation in the RV parking area – please park your RV in the parking lot on the left as you drive into the complex.

<u>USE OF GENERATORS:</u> Unless necessary for the conduct of the trial, generators are prohibited from running in the parking area between the two arenas during trial hours. Additionally, the trial committee reserves the right to require ANY generator be shut down if exhaust fumes are causing problems.

<u>FOOD</u>: There will be an on-site concessionaire selling breakfast and lunch items. Complimentary coffee, and breakfast items will be available to competitors until 10:00 am. Hot water will be available all day. If you volunteer and are assigned to work, you will receive tickets you can use at the concession. If you are scheduled to work after lunch, be sure to track down your Ring Crew Chief in the morning and ask for your tickets!

<u>WORKERS</u>: Thank You for working, we could not run this trial without your help! Workers will receive raffle tickets and a \$2 ticket for each class worked. A worker appreciation raffle will be held each afternoon. The \$2 tickets can be used at the food concession, any vendors present at the trial, or for future SDTC trial entry fees. If you save your \$2 tickets for future entry fees, you must exchange the \$2 tickets for one voucher equal to the total of your \$2 tickets before you leave the site. The individual \$2 vouchers become worthless after the event.

RESTRICTIONS ON VENDING/SELLING STUFF: In order to sell anything, anywhere on the trial grounds, you must pay Murieta a per day vendor fee plus carry a \$1,000,000 insurance policy (and have proof of insurance with you on the grounds). All vendors must set up in the vendor area. With the exception of our photographers/videographers, there will be no vending from the arena floor. This is not an SDTC requirement, but one set by Murieta Equine Center.

SCORING, QUESTIONS, POSTING: Scores will be posted in binders outside the scoring office and near awards as soon as possible after each jump height is completed. Please check your results as soon as possible so we may resolve any questions you may have before the judge forgets what your run was like! While it's true the score table is busy, we are never too busy to help you.

If you have any questions about anything other than scoring, or have any feedback about ways we can improve our trial don't be shy about saying something. Track down our Trial Chair, Jenny Cuccinello; our Trial Secretary, Mary Roseberry; our Awards coordinator, Pat White.

<u>AWARDS</u>: We will have your awards ready as soon as we can, but please be patient. AKC requires judges to review all scribe sheets prior to awards being available to competitors. In addition to rosettes for class placements and qualifying flats, there are special pins for Double Qualifying rounds, Triple Qualifying rounds, new titles; and a rosette for any MACH. If you might earn a MACH at this trial, please let our Trial Secretary know as soon as possible! Mary Roseberry <u>marybery@comcast.net</u>

<u>COURSE MAPS</u> will be available at the check in table. Please, take maps for only the classes you've entered. Novice and Open maps will be held in the office to insure that they are available for Novice and Open entrants. If you are entered in these classes, just ask the office for your copy.

<u>MEASURING</u>: The only dogs that require measuring are those without height cards or dogs over two years of age who only have one measurement. If you have a permanent height card or two measurements on a dog more than two years old or have a temporary height card for dogs less than two years old, you no longer need to submit or show height cards. Only if you have a dog over two years of age and do not have your permanent card will you need to be measured

<u>OFFICIAL HEIGHT CARD MEASUREMENTS:</u> Cindy Macklin is our volunteer measuring official for the weekend. Official measuring will be done periodically throughout the day. If you need a height measurement (dogs over two years of age without permanent height cards need at least two measurements), fill out your paperwork (available at the trial) and enquire at the office for measurement times. If your dog needs to be measured, you MUST be measured prior to running your first class.

<u>CONFLICTS</u>: Conflicts will be handled as needed. If you even think that you might have a conflict, notify your GATE STEWARD before your class begins or as soon as you know you have a problem. We will do everything we can do make sure you get your run, including resetting jump heights once after all dogs have run, as long as you have told us in advance that you may have a conflict.

ONLY THE GATE STEWARD OR OUR RING CREW CHIEFS (Julie O'Rourke, Karen Johnson or Patty Buchanan) MAY CHANGE THE RUNNING ORDER. HANDLERS MAY NOT MOVE

THEIR OWN DOGS. Handlers with multiple dogs will be separated by at least 10 dogs if at all possible, given the number of dogs in their jump height. If there are not 10 dogs between a handler's dog, it will be handled on a case by case basis. The first dog running will be moved UP in the running order to the maximum extent. Then, and only then, will the second dog be moved down until there are 10 dogs between them.
