In the event that both the score and time are the same, each dog will be tested again, individually, by performing a course as chosen by the judge. Handlers may have five minutes to re-walk the course.

- Only dogs that are eligible to be shown under AKC rules are allowed on the trial grounds during trial hours.
- If case of a tie for any prize, any dog that is not present for a run-off will forfeit its right to the prize. We are sorry but no awards will be mailed.
- Exhibitors are responsible for being at the ring on time for judging.
- Exhibitors are responsible for cleaning up after their dogs.

PLEASE NOTE: Rally is a separate event and is NOT considered an additional obedience entry.

CLOSING DATE: Thursday, January 5, 2017 at 6:00 PM after which entries cannot be accepted, cancelled or changed and must be at the address of the Trial Secretary. No telegraphed, telephoned, faxed, unsigned or incomplete entries will be accepted. Entries, including fees, must be at the address of the Trial Secretary prior to the closing date. Entries not on an Official AKC Entry Form or photocopies of forms without an Agreement and Rules on the reverse side of the Official AKC Entry Form are not acceptable. Checks returned by the bank for non-sufficient funds do not constitute a valid entry fee. A \$25 collection fee will be added to the amount of each check returned. No entry shall be made and no entry shall be accepted which specifies any condition as to its acceptance.

Any exhibitor with a bitch entered which comes into season after the close of entries will be refunded the entry fee for each entry for that bitch less a \$5.00 processing fee. Request for refund of entry fees must be provided to the Trial Secretary not less than 30 minutes before the start of the trial.

Apart from the exception noted in the paragraph above, entry fees will not be refunded in the event of errors or cancellation of entries after the published closing date, nor in the event a dog is absent, disqualified, sick, lame, excused by the Veterinarian or Judge, or barred from competition by the Trial Committee. If, because of riots, civil disturbances, fire, Act of God, act of a public enemy, strikes, extreme weather conditions or any other act or event beyond the control of the Sacramento Dog Training Club, it is impossible to open or complete the Trial, no refunds of entry fees will be made.

Please type or hand-write neatly on entries. Acknowledgement of acceptance of entry shall occur approximately one week before the date of the trials. **Formal confirmation and judging schedule will be sent by EMAIL.** If you do not receive a confirmation, contact the trial secretary immediately.

The Sacramento Dog Training Club and its Secretary assume no responsibility for incorrect entries. Please verify your information.

Exhibitors should follow their veterinarian's recommendation to assure their dogs are free of internal and external parasites, any communicable diseases, and have appropriate vaccinations.

Transfers (Move-Ups) will be allowed at these trials as provided for in Chapter 1, Section 16A, AKC Obedience Regulations. The transfer form must be given to the trial secretary a minimum of 30 minutes prior to the start of the trial.

Obedience and Rally classes will be judged in descending jump height order.

INSTRUCTIONS

1. (Variety) If you are entering a dog of breed in which there are varieties for show purposes, please designate the particular variety you are entering.
2. (Event Class) Consult the classification in this premium list. If the event class in which you are entering your dog is divided, then, in addition to designating the class, specify the particular division of the class in which you are entering your dog i.e. A or B division.
3. A dog must be entered in the name of the person who actually owned it at the time entries for an event closed. If a registered dog has been acquired by a new owner it must be entered in the name of the new owner in any event for which entries closed after the date of acquirement, regardless of whether the new owner has received the registration certificate indicating that the dog is recorded in his/her name. State on entry form whether transfer application has been mailed to the AKC. (For complete rules, refer to Chapter 11, Section 3.)
4. Dogs listed the AKC Canine Partners Program may be eligible to enter all-breed AKC Obedience and Rally trials at the club's option. These dogs should be listed as All American Dog and must include their AKC Number on the entry form and check the AKC No. box. Sire and Dam information shall remain blank for mixed breed entries.

AGREEMENT

I certify that I am the actual owner of the dog, or that I am the duly authorized agent of the actual owner whose name I have entered above.
