**Rules at Enter**

- Dogs must be at least 1 year of age
- Any AKC eligible dog may enter. They do not have to be entered in the regular trials at this event nor do they have to be AKC registered yet.
- Dogs may be entered multiple times in the same class, but a maximum of 3 runs for any one dog per class
- A jump height card is not required nor are the dogs required to be measured.

**ENTRY FEE: \$7.00 per run pre-entry; \$10.00 per run after Nov 15, 2018**

Opening day for pre-entries is October 1 2018, 9 AM  
Pre-entries must be received by November 15, 2018 6 PM

**Day of Match: \$10.00 per run**

### **Exhibitor Rules:**

- Toys and clickers are allowed in the ring
- Food is NOT allowed in the ring
- Maximum course time will be enforced.
- No harsh verbal or physical corrections allowed
- Excusal for do fouling the ring

### **General Info:**

- Classes offered: Standard and JWW. One course will be set for each class. One class may follow the other or they may be in separate rings.
- You may run the numbered courses or your own pattern.
- No scoring or ribbons offered.
- Match will begin 30 minutes following the conclusion of the judging.
- Entry fee will not be refunded if the dog is absent, disqualified, excused, or barred from competition by action of the trial committee. If, because of riots, civil disturbances, or other acts beyond the control of the management it is impossible to open or complete the match, no refund of entry fees will be made.
