- I agree to assume all responsibility and liability for any injury which may have been allegedly caused directly or indirectly to any person, animal, or thing by the act of this dog or any dog/person while in or upon the Sycamore Lane training premises, All Dogs Sports Park LLC, or grounds or near any entrance thereto. I further agree to hold Sycamore Lane and All Dogs Sports Park LLC, owners, trainers, and employees harmless from any and all claims and liabilities of every nature which might arise from myself and this dog's or any dog's participation in the match or from any other cause.

VACCINATION POLICY

In accordance with California State Law, we require all dogs are immunized for Canine Rabies. We also recommend all dogs are immunized for Canine Influenza Virus, Canine Parvovirus, Distemper Virus, and Adenovirus and Canine Leptospira. **If your dog has not been immunized, you must initial in the box below to indicate that you know the risk and that you assume any and all risks to your dog's health should he/she come in contact with any canine virus before, during or after your dog's participation in our event.**

I understand the risks involved in not getting my dog vaccinated as described above. I will not hold anyone but myself liable should my dog be subjected to any virus so described.
