

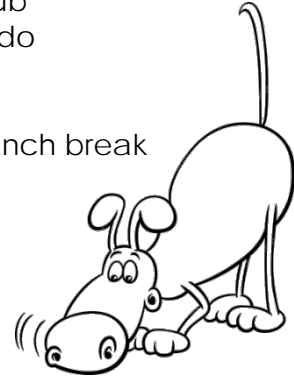
# Two Day Seminar Skills for Tracking Dog Excellent
